## NOTICE OF CONTEMPLATED CLOSED SESSION

**Monday, July 2, 2018**

**4:30 pm**

The Board of Education of West Bend Joint School District No. 1 will convene in closed session beginning at 4:30 p.m. on Monday, July 2, 2018 in the Upper Level Conference Room at the Education Service Center located at 735 South Main, West Bend. The purpose of the hearing is to consider the recommendation of the administration that a student be expelled for repeated refusal and neglect to obey school rules and/or for engaging in conduct while at school or while under the supervision of a school authority that endangered the property, health, or safety of others.

### **Contemplated Closed Session**

Pursuant to Wis. Stat. § 19.85(1)(f): “considering financial, medical, social or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations.”

Pursuant to Wis. Stat. § 19.85(1)(a): “Deliberating concerning a case which was the subject of any judicial or quasi-judicial trial or hearing before that governmental body.”

The Board will take action as necessary in closed session following its deliberations.
